March 19 for July bar examinations; or

October 19 for February bar examinations.

As consideration for TCP's review of this Application, I agree that any controversy or claim arising out of or relating to this Application and/or Scholarship including without limitation the interpretation, validity, enforceability or breach thereof, shall be settled by binding arbitration administered by Arbitration Resolution Services, Inc. (ARS). The parties shall be bound by any and all rules of ARS, which can be found at www.arbresolutions.com. If the arbitrator determines that a party has generally prevailed in the arbitration proceeding, then the arbitrator shall award to that party its reasonable out-of-pocket expenses related to the arbitration, including filing fees, arbitrator compensation, attorney's fees and legal costs. The award shall be in writing, signed by the arbitrator, and shall include a statement regarding the reasons for disposition of any claim. Arbitration is conducted virtually so neither party is required to travel. An award of arbitration may be confirmed in a court of competent jurisdiction. Notwithstanding the foregoing, either party may immediately bring a proceeding seeking preliminary injunctive relief in only Loudon County, Virginia which shall be deemed having jurisdiction thereof which shall remain in effect until a final award is made in the arbitration. The arbitration proceedings and arbitration award shall be maintained by the parties as strictly confidential, except as is otherwise required by court order or as is necessary to confirm, vacate or enforce the award and for disclosure in confidence to the parties' respective attorneys, tax advisors and senior management and to family members of a party who is an individual.
